- 3) Copy of parents' most recent pay stub

— PLEASE NOTE —

A copy of parents' federal income tax return must be included for consideration of any Financial Assistance request. Please note that this Tuition Assistance Request is due **PRIOR** to the US Federal tax deadline. The applicant may submit their family's 2011 tax returns if they are prepared by our deadline. If the 2011 returns are not prepared by the application deadline, the applicant may submit their 2010 returns accompanied by a description in the *Statement of Need* (page 2) of how the family's financial circumstances may have changed since 2010. Tax returns for 2011 should be forwarded to our office as soon as they are prepared. If you have concerns about this requirement, please contact our office.
